Brief Facts of the case:-

1. In his RTI application, the appellant asked for information regarding status and progress report of his letter dated 16.12.2019, sent to CIC.

Reply of CPIO:-

2. In response to the RTI application Sh. S. C. Sharma, CPIO, vide his letter dated 17.01.2020 informed the appellant that:

“Your letter dated 16.12.2019 regarding early hearing of your appeal No. CIC/CRAIL/A/2019/140599 (registered on 21.08.2019) was put up to the Hon’ble Information Commissioner and the undersigned has been directed to ‘list the case on due date’. Accordingly, the above appeal will be listed for hearing on its turn.”

Ground of First Appeal:-

3. Aggrieved with reply furnished by the CPIO, the appellant filed First Appeal on following ground:

“1. Requested for permission for Release the matter in media for the corruption going till date in central Railway CSTM Mumbai. I have not received any clarification regarding the same.

2. And also requested for early date of hearing as per 2 year’s of gap for hearing meanwhile the PIO of central Railway will be transfer to some other Post and corruption will be continuing.

The PIO of central Railway Divisional Engineer (LM) is denying all my RTI request with mala fide intension and knowingly blocking the papers to me. So that truth won’t

come out. Therefore the PIO of central Railway department is taking advantage of time period.

3. There's a huge scam regarding this matter, requesting early date of hearing."

Decision with reasons:-

4. On perusal of the Appeal, RTI application and CPIO's reply it is observed that the appellant is seeking information on his letter dated 16.12.2019 sent to CIC for early hearing in his second appeal No. CIC/CRAIL/A/2019/140599, which has been registered on 21.08.2019. In this regard, the CPIO has informed the factual position to the appellant that his request was put before the Hon'ble Information Commissioner and as per the direction the case will be listed for hearing on its turn. Hence, the information supplied is as per the information asked for and therefore, further intervention is not required on the part of the FAA, in the matter.

As far as the other grounds raised in the first appeal, were not a part of information sought for by the appellant, hence the same cannot be grounds of 1st appeal.

5. The appeal is being disposed of accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi - 110 067 against this order within 90 days.
