Brief facts of the case:-

The appellant, through his RTI application, asked for following information:

“information is requested under RTI Act 2005 Designation was posts created on permanent basis and Recruitment Rules connected with each such permanent posts, particularly for Registrar and Dy. Registrar and details of positions created as Consultants on contract basis not appointed against these permanent posts may also be provided. If appointment of Consultants on contract basis against these created permanent posts may also be provided separately”.

Reply by CPIO :-

2. In response to the above RTI application, the CPIO, Shri C. Vinod Babu, Consultant (SO) & CPIO provided the information by taking assistance from Shri V. P. Singh, SO (Consultant) Admn, u/s 5(4) of RTI Act, 2005.

Ground of First Appeal:-

3. Aggrieved with the reply provided by the CPIO, the appellant filed first appeal before the First Appellate Authority on following ground:

CPIO did not provide the following information with the sole purpose of harassing the information seeker Designation was posts created on permanent basis and Recruitment Rules connected with each such permanent posts, particularly for Registrar and Dy. Registrar, as these positions are to be occupied by officer i.e. can be given to Group A or Group B officers only and not to Consultants on contract basis. Please note that Recruitment Rules of all posts created in CIC is required. Total number of posts created in CIC are given as attachment. Hence Recruitment Rules of all posts created is requested. Total number of posts created in CIC are 144 and hence Recruitment Rules of all 144 posts are required.

Decision with Reason:-

4. On perusal of the Appeal, RTI application and CPIO's reply, it is observed that the reply given to the appellant is as per the information asked for by the appellant, therefore no further intervention is required on the part of the FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
