Brief facts of the case:-

The appellant, through his RTI application, asked for following information:

“information is requested under RTI Act 2005 Designation was posts created on permanent basis including for Registrar and Dy. Registrar and details of positions created as Consultants on contract basis not appointed against these permanent posts may also be provided. If appointment of Consultants on contract basis against these created permanent posts may also be provided separately”.

Reply by CPIO :-

2. In response to the above RTI application, the CPIO, Shri C. Vinod Babu, after taking assistance u/s 5 (4) of the RTI Act from Sh. V. P. Singh, SO (Consultant) provided the copy of DoPT office order containing details of posts (designation wise) and also informed that “no consultant post has been created in the Commission on permanent basis.”

Ground of First Appeal:-

3. Aggrieved with the reply provided by the CPIO, the appellant filed first appeal before the First Appellate Authority on following ground:

“CPIO has not provided the following information Details of positions created as Consultants on contract basis not appointed against these permanent posts . If appointment of Consultants on contract basis against these created permanent posts has been done the same may also be provided separately.”

Decision with Reason:-

4. On perusal of the Appeal, RTI application and CPIO's reply, it is observed that information has been partly provided by CPIO in respect of information stated in ground of appeal. Therefore CPIO Sh. C. Vinod Babu is directed to revisit the matter and provide appropriate information within 15 days of receipt of this order.

5. The appeal is being disposed of accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
