Brief Facts of the case:-

1. The Appellant, through his RTI application, asked for following information:

"Under section 06 of RTI Act- 2005 and for the public interest, kindly provide Information of reply or Response letter from CIC, New Delhi, against my i.e. applicant Vijay Kumar Mankar admitted 2nd appeal no. CIC/MORLY/A/2019/656685 of date-12-11-2019 as till date no response received by CIC".

Reply of CPIO:-

2. In response to the above RTI application, the CPIO, Sh. S. C. Sharma provided following information to the appellant:

"On going through the aforesaid RTI application, it is seen that no specific information pertaining to CIC has been asked for in the application.

Further it is seen that you have filed a second appeal before the Commission against the Railway authorities against your RTI application dated 20.06.2019, which stand disposed by the concerned CPIO and also the first appeal was also disposed by the FAA of the concerned authority.

As far as providing the information by the Commission is concerned, it is to intimate that your second appeal which was registered in the CIC with file No. CIC/MORLY/A/2019/656685, is yet pending since at present the cases registered during August, 2018, are being listed. Therefore, as and when your case will be listed for hearing, you may explain your position to get the requisitioned information, since CIC cannot interfere before listing the case. Please bear with us till your case is listed for hearing".

Ground of First Appeal:-

3. Aggrieved with the reply sent by the CPIO, Appellant filed first appeal stating, "details not provided" and requested that "kindly provide photocopy of CIC letter on my CIC Second Appeal RTI case No.CIC/MORLY/A/2019/656685 of date 12.11.19"

Decision with reasons:-

4. On perusal of the Appeal, RTI application and the reply sent by the CPIO, it is observed that CPIO, Sh. S. C. Sharma has already provided the status of the Second Appeal No. CIC/MORLY/A/2019/656685 dated 12.11.2019 to the Appellant, wherein he has been informed that his above second appeal is pending with the Commission for disposal. The CPIO in his reply has also intimated him that presently (at the time of reply), the cases registered with the Commission during August, 2018, are being taken up for hearing.

The information provided by the CPIO is complete and as per the provision of the RTI Act 2005, and, therefore, no further intervention is required on the part of the FAA, in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
