Brief Facts of the case:-

The Appellant, through his RTI applications, has asked for following information related to CIC Order No. CIC/BKOIN/A/2018/118606:-

- a. Please let me know Show Cause Notice issued to respondant/accussed bank provide C.T.C. copy.
- b. Please let me know penalty imposed on respondant bank.
- c. Please provide me copy of reply of respondant bank to Show Cause Notice. If penalty imposed provide C.T.C. copy.
- d. If penalty not imposed, kindly provide info not imposed as per direction of CIC order.

2. Reply of CPIO.

The point wise reply given by Sh. R. Sitarama Murthy, CPIO on 16.03.2020 is as follow:-

- (A). The Show Cause Notice is yet to be issued in response to Hon'ble Commissioner's order dated 11.12.2019.
- (B&D)Show Cause hearing is yet to take place and hence imposition of penalty does not arise.
- (C). Since Show Cause Notice is yet to be issued, providing copy of reply of respondant bank in response to show-cause notice does not arise.

3. Ground of First Appeal:-

In First Appeal application, Appellant has mentioned following grounds for appeal:-

"Since Hon'ble Commissioner's order dated 11.12.2019, please let me know as per order till date even after three months two weeks no Show Cause Notice issued to bank/branch in spite of mention of Show Cause Notice in order dated 11.12.2019. Please provide info no Show Cause Notice issued till date".

4. Decision with reasons:-

On perusal of the Appeal, RTI application and reply given by CPIO, it is observed that the information provided by CPIO, Sh. R. Sitarama Murthy is as per information sought by the Appellant. It is pertinent to mention that under the provisions of the RTI Act, 2005 only such information as is available and existing and held by the public authority or is under control of the Public Authority can be provided. The PIO is not supposed to create information that is not a part of the record. Hence the reply, given by the CPIO is as per the provision of the RTI Act, 2005. Therefore, no further intervention is required on the part of the FAA.

- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi $-110\,067$ against this order within 90 days.
