Brief Facts of the case:-

1. The Appellant has sought following information on his letter dated 16.03.2020, addressed to Sh. Y. K. Sinha, Hon'ble Information Commissioner regarding Non-compliance of CIC Order No. CIC/ADDDM/A/2017/125075: -

1. Action taken report against Registrar of Societies and Addl. Distt. Majistrate if action already taken.
2. Status of my complaint dt 16.03.2020 for Non-Compliance of CIC order dt. 10.12.2019 if under process.

Reply of CPIO:-

2. CPIO, Sh. R P Grover has provided the following information vide letter dated 10.07.2020:-

- A. Your letter dated 16.03.2020 received in the Commission vide dairy no. 112202 dated 16.03.2020 and same has been electronically linked with the concern appeal files.
- B. As per record, no action is taken on the said letter yet.

Ground of First Appeal:-

3. Appellant had submitted First Appeal on 13.07.2020 and after receipt of CPIO's reply on 21.07.2020, has filed another appeal on 22.07.2020 and both appeals have been received in the office of FAA on 30.07.2020. Aggrieved with the reply of CPIO, the Appellant has stated in his First Appeal dated 22.07.2020 that: -

"reply from CPIO is not satisfactory as the order of Hon'ble Information Commissioner is dt. 10.12.2019 and my complaint for non compliance is dt 16.03.2020".

Decision with reasons:-

4. On perusal of the Appeals, RTI application and replies given by CPIO, it is seen that the said RTI application was received on 11.06.2020 in the RTI Cell of the Commission and forwarded to Sh. R P Grover, CPIO, who has provided the information vide letter dated 10.07.2020. Sh. R P Grover is directed to revisit the information given and provide the information as sought by the Appellant and within ten days under the provisions of RTI Act, 2005.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
