Brief Facts of the case:-

1. The Appellant has sought following information vide his RTI application dated 25.05.2020: -

The CIC, what kind of action taken on 2nd Appeal No. CIC/DITIN/A/2017/155081-BJ and CIC/CCACH/A/2018/140175-BJ, Dairy Nos. (i) 172046 (ii) 172047 dt. 11.12.2018.

The CIC, conducted hearing on these cases dated 01.11.2018 and issue the decisions dated 02.11.2018, but they are not obeying the CIC order (Chennai and Vishakhapatnam offices).

Dated 07.12.2018 and 28.10.2019 we are sending Non-compliance complaint. Till today we are not receive any justice and any information, please take a serious action on Income Tax Deptt (INV) officers. So please accept my RTI application and issue the information through RTI Act.

Reply of CPIO:-

2. CPIO, Sh. S C Sharma has provided the following information vide letter dated 22.06.2020:-

"On perusal of the above RTI application, it is seen that you had asked for status of non-compliance of CIC decision in case No. CIC/DITIN/A/2017/155081 and case No. CIC/CCACH/A/2018/140175, submitted vide letter dated 07.12.2018 and 28.20.2019. On perusal of the file, it is seen that no specific action has been taken on your letters. Further, it is seen from the file that the CPIO, with reference to CIC orders have already replies/complied the orders vide letter dated 19.11.2018 and letter dated 29.11.2018".

Ground of First Appeal:-

3. Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that: -
"Your office CPIO send a reply dated 22.06.2020 received on 03.07.2020, but i am not satisfy"

Decision with reasons:-

4. On perusal of the Appeal, RTI application and replies given by CPIO, it is seen that the said RTI application was received on 12.06.2020 in the RTI Cell of the Commission and forwarded to Sh. S C Sharma, CPIO, who has provided the information vide letter dated 22.06.2020. The information given by Sh. S C Sharma is as information sought by the Appellant and within the time limit under the provisions of RTI Act, 2005. Other issues mentioned in First Appeal application are not a part of the RTI application and hence, cannot be considered by the Appellate authority. Hence, no further intervention is required on the part of the FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi - 110 067 against this order within 90 days.
