1. Brief Facts of the case:-

The Appellant has sent a written submission dated 11.02.2020 related to CIC Order No. CIC/DDATY/A/2018/143913-BJ and CIC/DDATY/A/2019/161953-BJ dated 23.01.2020 and asked for the following information through his RTI application dated 21.03.2020:-

"Kindly provide me the status of my request dated 11.02.2020 to facilitate further course of action as per the RTI Act, 2005. The information may please be supplied by post within the stipulated period".

2. Reply of CPIO.

CPIO, Sh. K. L. Das has provided the following information vide his letter dated 08.07.2020:-

"You have sought information regarding status of your letter dated 11.02.2020. In this connection, it is informed that decision once made by Commission is final and there is no provision for review the order under RTI Act, 2005. Our letter No.CIC/DDATY/A/2018/143913 + CIC/DDATY/A/2019/161953- DR(IC-BJ) dated 06.07.2020 in this connection also refers".

3. Ground of First Appeal:-

In opening para of First Appeal application, Appellant has mentioned that "i am aggrieved by incomplete and incorrect information provided by CPIO for my RTI application". He has further stated as "PRAYER/PLEA" that "CPIO, CIC, New Delhi has not provided status of my earlier letter dated 11.02.2020.

4. Decision with reasons:-

On perusal of the Appeal, RTI application and reply given by CPIO, it is observed that the said RTI application dated 21.03.2020 (sent on 26.05.2020 by applicant as mentioned in First appeal application) was received on 09.06.2020 in the RTI Cell of the Commission and CPIO, Sh. K. L. Das has provided the information vide setter gated ps.07.2020, within the time limit
