1. Brief Facts of the case:-

Appellant has filed two RTI applications requesting same information, First application received directly in Central Information Commission through online RTI portal, while other application is received in Central Information Commission through transfer from other Public Authority on 12.05.2020 with original RTI No. DITEC/R/T/20/00167.

The Appellant, through his RTI applications, has asked for following information:-

- 1. How many states provides platform for citizen to first request under RTI through State Information Commissioner portal via online/digital
- 2. Which States are Allow citizen to first request under RTI through State Information Commissioner portal via Online/ Digital. Please provide the name with URL links
- 3. States does not have any digital/online utility or portal to accept e-request of RTI. Is there any planning or Considering providing online digital mode for e-request of RTI through State Information Commissionerate portal.
- 4. How many States have provide similar services or processing of e-request of RTI as www.rtionline.gov.in for its citizen of State,

2. Reply of CPIO.

Reply given by Sh. Jeevan Chandra, CPIO on 21.05.2020 is as follow:-

"The information related to the State(s) can be obtained from the Office of Information Commissioners of the individual State. The information asked for all the points is not available with the Central Information Commission".

3. Ground of First Appeal:-

In First Appeal application, Appellant has mentioned that – "Refused access to Information requested". It is also mentioned that:-

CIC is supreme authority in the nation. This basic information should have with CIC. CIC will be able to straighten to make RTI application easily and transparent manner of disposal of RTI. In this situation state should give option to citizen for making/raise RTI application through digital mode.

4. Decision with reasons:-

On perusal of the Appeal, RTI application and reply given by CPIO, it is observed that the information provided by CPIO, Sh. Jeevan Chandra is as per information sought by the Appellant. The information supplied is factual and as per provisions of RTI Act, 2005. Hence, the grounds stated in the appeal as "Refused access to Information Requested" is infructuous and no further intervention is required on part of FAA in this matter.

- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi $-110\ 067$ against this order within 90 days.
