**1. Brief Facts of the case:-**

The Appellant, through his RTI Application, has asked for information regarding receipt of his complaint dated 17.10.2019 and a complaint/2<sup>nd</sup> Appeal dated 02.05.2020, their diary No. and the dated of hearing fixed by CIC in above matters.

**2. Reply of CPIO.**

In response to the above RTI Application the CPIO, Shri Krishan Avtar Talwar, Deputy Secretary & CPIO, Central Registry-I, after seeking assistance u/s 5(4) of I/c Dak Section and Section Officer, CR-II, informed the Appellant that the complaint dated 17.10.2019 was diarized vide diary No. 150352/18.10.2019 and was linked with File No. CIC/MCDND/C/2016/300191 on 21.10.2019, which was further approved by the DR of concerned Registry on 22.10.2019. In respect to complaint/2<sup>nd</sup> Appeal dated 02.05.2020, the Appellant was informed that was diarized vide diary No. 114168/05.05.2020 and sent to Central Registry, which was further put on file in e-office for the purpose of seeking examination by the Registry of Shri Yashvardhan Kumar Sinha, Central Information Commission in accordance with the provision contained in Para 2(ii) of circular No. CIC/22/2016-Rgr. Dated 16.06.2016.

**3. Ground of First Appeal:**

Aggrieved with the reply sent by the CPIO, the appellant has filed his First Appeal on following ground:

1. "CPIO has replied to my RTI application dated 12.06.2020 that my letter, CIC Diary No. 114168 dated 05.05.20, has been placed on file for examination by Dy. Registrar of Sh. Yashvardhan Kumar Sinha, Information Commissioner.
2. But this reply does not indicate which of my two aforementioned complaints has been placed on file for examination. CPIO should have given the date of my complaint to enable me to connect my papers. I cannot figure out whether he is referring to my complaint dated 17 Oct. 2019 or 02 May 2020. This should be clarified."

**4. Decision with reasons:**

On perusal of the Appeal, RTI application and the reply, sent by the CPIO along with annexures, it is clear that the complaint dated 17.10.2019, after getting diarized vide diary No. 150352/18.10.2019, was linked with File No. CIC/MCDND/C/2016/300191 on 21.10.2019 and was approved by the DR of concerned Registry on 22.10.2019. Further, complaint/2<sup>nd</sup> Appeal dated 02.05.2020, diarized vide dairy No. 114168/05.05.2020, sent to Central Registry, which was further put on file in e-office for the purpose of seeking examination by the Registry of Shri Yashvardhan Kumar Sinha, Central Information Commission. Hence, the reply sent by the CPIO is clear and further intervention on behalf of the FAA is not required in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
