**Brief Facts of the case:-**

1. The Appellant has sought following information vide his RTI application dated 25.06.2020: -

Certified copy of action taken status at CIC, New Delhi on my representation dated 13/12. October 2019 (Copy enclosed), Diary No. 150329 dated 18-10-2020 addressed to Shri S. S. Rohilla, Designated officer, CIC, New Delhi submitted through register post on 14-10-2019 along with file noting, correspondence, related documents.”

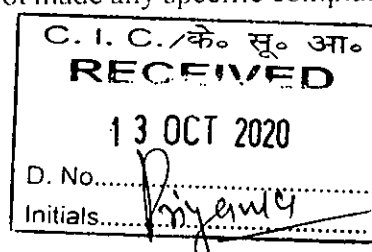
**Reply of CPIO:-**

2. The CPIO, Sh. S C Sharma, DR to IC-NG, vide his letter dated 20.07.2020, provided following information to the Appellant:

“Certified copy of note-sheet regarding compliance of the Commission’s order in case No. CIC/HWPG/A/2017/608159 is enclosed. As may be seen therefrom, the case has been closed following compliance of the Commission’s direction by the Public Authority. A copy of the order dated 10.12.2019 is also enclosed.”

**Ground of First Appeal:-**

3. Aggrieved with the reply, given by the CPIO, the Appellant has filed First Appeal. The appellant, in his First Appeal Petition, has however not made any specific complain against the



information provided by the CPIO, but he has reiterated the desired information again and has requested to provide it only.

**Decision with reasons:-**

4. On perusal of First Appeal, RTI Application and the information provided by the CPIO, it is observed that in respect to the information asked for by the Appellant, the CPIO has provided the factual information as is available in record. It is important to note that under the provisions of Section 2(f) of the RTI Act, only such information, as is available and existing and held by the public authority or is under control of the public authority can be provided by a PIO. Accordingly, the information sent by the CPIO, CIC is factual and as per the provision of the RTI Act, 2005. Hence, no further intervention is required on the part of FAA in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
