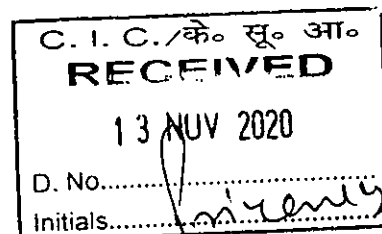

1. Brief Facts of the case:-

The Appellant, through his RTI Application, asked for following information with a request to send the these information on his E-mail ashwani091083@gmail.com :

1. "Give every copy of Second Appeal ad decision given by the information commission which fall within the ambit of Section 8(1)(d) of RTI Act, 2005. Here every copy of Second Appeal on which decision is done are latest ten cases.
2. Audit report of CIC (during 2015-2020).
3. Give details of every fund received by CIC yearwise during 2015-2020 and also provide details of every bill through which it is spend during 2015-2020.
4. Mention the years during which building of the CIC, made mention name of constructing agency, amount transferred to constructive agency for construction of CIC building. Give every bill through which the amount for construction is spend by the construction Agency during construction of CIC building."

2. Reply of CPIO.

In response to the above RTI Application the CPIO, Sh. S. K. Rabbani, Dy. Secretary (GA), through his letter dated 23.09.2020 provided following information against point nos. 2 to 4 to the Appellant:

2. "The Information is exempt from disclosure u/s 8.1 of the RTI Act as it would cause breach of privilege of the Parliament.
3. The information is huge in nature and requires compilation. The information cannot be provided as per provision contained in section 7(9) of the RTI Act as it would disproportionately divert the resources of the Commission.

4. The total amount spent on construction of CIC building is Rs. 66.40 Crores. NBCC is the Agency that was involved in the construction of CIC building. The building was constructed during the period 2015 to 2017."

3. Ground of First Appeal:

The Appellant, in his First Appeal petition has stated that no reply has been received by him for the information asked for by him on his E-mail within the time mandated under the Act.

4. Decision with reasons:

On perusal of the Appeal, RTI application and the reply sent by the CPIO, it is observed that the CPIO, Sh. S. K. Rabbani, Dy. Secretary (GA), through his letter dated 23.09.2020 has provided information to the Appellant against point nos. 2 to 4 of the Application vide his letter dated 23.09.2020, which has been sent by post, whereas, the Appellant in his RTI Application has requested to send the reply on his E-mail.

In light of the above, the CPIO, Sh. S. K. Rabbani, Dy. Secretary (GA) is directed to send his reply dated 23.09.2020 to the Appellant on his E-mail ashwani091083@gmail.com within 15 days after receipt of this order. Consequently, the CPIO, RTI Cell, is also directed to send the reply against point no. 1 of RTI Application to the Appellant on his above mentioned E-mail within 15 days after receipt of this order.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi - 110 067 against this order within 90 days.
