1. **Brief Facts of the case:-**

The Appellant through his RTI Application dated 26.08.2020 has sought the information against Point No. A, B, C and D related to Monitoring and Reporting under provisions of section 25 of the RTI Act, 2005.

2. **Reply of CPIO:-**

CPIO, Sh. Amit Tiwari has provided the same information for point A, B, C and D stating that “The desired information is available in the Annual Report of the Commission. The Annual Report is available on CIC website i.e. [www.cic.gov.in](http://www.cic.gov.in) - > Annual reports. The direct link for the Annual report is <https://cic.gov.in/reports/37>.”

CPIO has also intimated that “Annual Reports till 2018-19 is available on CIC website and the report for the year 2019-20 is under compilation”.

3. **Ground of First Appeal:-**

On non receipt of the information, The Appellant has filed the First Appeal petition dated 30.09.2020 and requested for desired information.

4. **Decision with reasons:-**

Ongoing through the RTI Application, the reply sent by the CPIO and the First Appeal filed by the Appellant, it is observed that the said RTI application has been received in RTI Cell of the Commission on 04.09.2020 and the CPIO, CIC has provided the reply vide letter No. 14011/1/2020-MR-CIC dated 23.09.2020, within the time limit given in RTI Act. The CPIO, CIC in his reply against point No. A, B, C and D, has informed the Appellant that the desired information is available on the website of the Commission and once information has been provided in public domain and on the website, the information is no longer held by or under the control of any public authority and hence, is no longer accessible as ‘Right to information’ as has been observed by Delhi High Court in the matter of *Registrar of Companies & Ors vs. Dharemdra Kumar Garg & Ors* [W.P.(C) 11271/2009]. Hence information provided by the CPIO is as per the provision of RTI Act, 2005. Therefore, no intervention is required on behalf of FAA in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
