1. Brief Facts of the case:-

The Appellant has asked for following information regarding his application dated 10.07.2020 before the Hon'ble CIC :

- 1. Please provide the daily progress made on my application.
- 2. Please give the names and designation of the officials with whom my application was lying during this period. Please intimate the period when it was lying with which officer and what was the action taken by that official during that period.
- 3. Please give the proof of receipt and dispatch of my application in the office of each of these officials.
- 4. According to your rules-or-citizens charter or any other order in how many days should such a matter be dealt with and resolved. Please provide copy of these rules.
- 5. The above officials have not adhered to the time limit mentioned in these rules. Are these officials guilty of violating these rules and hence guilty of misconduct under their conduct rules. Please give a copy of their conduct rule, which they have violated the above mentioned rule.
- 6. These officials have caused serious mental injury to me by making me run around all this while. Are these officials guilty of causing mental harassment to the public?
- 7. What action can be taken against these officials for violating all the above rules and for causing mental agony to the public? By when this action would be taken?

- 8. By when will my problem be resolved now?
- 9. Permission may please be grant to go before Court of Law.

2. Reply of CPIO.

In response to the above RTI Application the CPIO, Sh. R. P. Grover, DR to IC (YS) through his letter dated 14.10.2020 provided following point-wise information to the Appellant:

3. Ground of First Appeal:

The Appellant, in his First Appeal petition dated 26.10.2020, has mentioned that, "Appellant has already been submitted the first appeal within specific period on dated 08-10-2020" but his First Appeal petition dated 08.10.2020 is not matched with his RTI application. In Point No. 1 of First Appeal petition dated 08.10.2020, Appellant has mentioned that "the Ld CPIO/Chief Commissioner/CIC was approached by the Appellate to provide certified copy/CD after inspection of the said records" but as per his RTI application, neither he has asked for any certified copy nor any CD and inspection of records.

4. Decision with reasons:

On perusal of the Appeal, RTI application and the information sent by the CPIO, it is observed that the information provided by CPIO is as per the provisions of the RTI Act, 2005, Therefore, no intervention is required on behalf of the FAA in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi $- 110\ 067$ against this order within 90 days.
