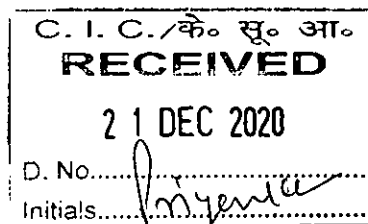

Brief Facts of the case:-

1. The Appellant, through his RTI application, has asked for the following information:-

“Kindly supply the comply the hearing dt. 6.7.2020 order passed at 7.7.2020 (Diary No. 129062/29.9.2020) and stamped was made on 25.7.2020 passed by CIC, New Delhi regarding allotment flats as well as action taken report of police” and

“Kindly provide what action taken report has been taken in this respect and the same may also be sent accordingly”.

Reply of CPIO:-

2. CPIO Sh. R. P. Grover has provided the following information to the Appellant vide his letter dated 28.10.2020:-

“In compliance of decision dated 07.07.2020, respondent authority PMO has submit the compliance report dated 19.10.2020 address to you with a copy to the Commission. Same has been received by you. However the copy of letter dated 19.10.2020 with enclosure is enclosed”.

Ground of First Appeal:-

3. On perusal of the First Appeal petition, it seems that this petition is against CPIO of some other Public Authority, not against the CPIO of CIC, as the Appellant has not mentioned any point of dissatisfaction with the reply of CPIO, CIC.

Decision with reasons:-

4. On perusal of the First Appeal petition, RTI application and reply given by the CPIO, it is observed that reply given by Sh. R. P. Grover, CPIO, CIC is factual and as per the provisions of the RTI Act, 2005. Matter related to other Public Authority doesn't covered under jurisdiction of FAA of CIC. Hence, no intervention is required on behalf of the FAA in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
