**Reply of CPIO:-**

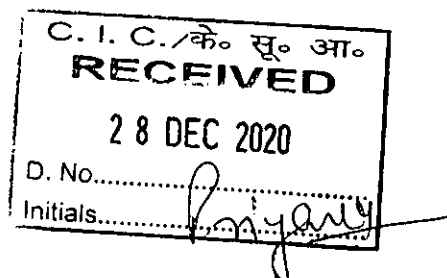
2. CPIO Shri A.K.Assija has replied to the Appellant as under vide his letter dated 06.11.2020:-

**Decision with reasons:-**

On perusal of the First Appeal petition, RTI application and reply given by the CPIO, it is observed that Shri A.K.Assija, CPIO, CIC has already provided the requisite information as per the provisions of the RTI Act, 2005. The CIC order/decision dated 07.07.2020 can also be accessed through “Decisions” on the CIC website by entering file no. CIC/PRSEC/A/2019/127633. Hence, no intervention is required on behalf of the FAA in this matter.
