Brief Facts of the case:-

1. The Appellant, through his RTI application, has referred CIC decision in appeal no. CIC/SA/A/2015/001384 dated 10.02.2016 and asked for the following information:-
“1. What action could be taken against the respondent Public Authority the Registrar of Cooperative Societies for Grave Contempt shown to the Order of Hon’ble CIC, and
2. Who will take the punitive action against the respondent Registrar of Cooperative Societies, GNCTD for the Contemptuous Disregard shown to the Order of Hon’ble CIC by him.”

Reply of CPIO:-

2. CPIO Shri R.P. Grover has replied to the Appellant as under vide letter dated 25.11.2020:-
“A. As per section 20 of RTI Act of 2005, if needed.
B. As per point no.1”

Ground of First Appeal:-

3. Information not provided by PIO, CIC, New Delhi.

Decision with reasons:-

4. On perusal of the First Appeal petition, RTI application and reply given by the CPIO, it is observed that reply given by Shri R.P. Grover, CPIO, CIC is factual and as per the provisions of the RTI Act, 2005. As per the provision of Section 2(f) of RTI Act, 2005 only such information as is available and existing and held by the public authority or is under control of the public authority can be provided by a PIO. The PIO is not supposed to create or collect information that is not a part of the record. Therefore, no intervention is required on behalf of the FAA in this matter.
5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
