“As per available record, no action has been taken on your letter 06.10.2020.”

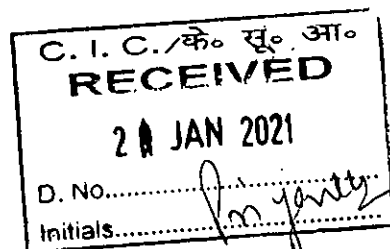
**Ground of First Appeal:-**


