**Brief Facts of the case:-**

1. The Applicant, through his RTI application, has asked for a Copy of the Commission's decision in respect of Second Appeal hearing attended by his daughter and himself on 10.11.2020.

2. CPIO Shri S.C.Sharma has forwarded a copy of Order No. CIC/DGITV/A/2019/109250 as requested by the applicant.

**Ground of First Appeal:-**

3. In his First Appeal, the Appellant mentioned that he did not receive revised reply to his RTI application and a copy of written submissions as per Commission's directions given to the Respondents viz., The CPIO, O/o DGIT(Vig.), New Delhi and CPIO, PDIT(Inv), Chennai.

**Decision with reasons:-**

On perusal of the First Appeal petition, RTI application and reply given by the CPIO, it is observed that the reply given by Shri S.C.Sharma, CPIO on the RTI Appeal is factual and as per the provisions of the RTI Act, 2005. The Appellant has requested for information which was not sought in the RTI application and hence is not entertained. Therefore, no intervention is required on behalf of the FAA in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
