## I. Brief Facts of the case:-

## III. Ground of First Appeal:-

The Appellant mentioned that a ridiculous reply received from CPIO (Legal Cell) vide letter dated 22.01.2021.

## IV. Decision with reasons:-

On perusal of the First Appeal petition. RTl application and reply given by the CPIO. it is observed that the applicant had referred his complaint and 5 reminders and the reply given by Smt Soniya, CPIO. CIC is incomplete. The CPIO (Legal Cell) is directed to revisit the reply and provide complete information to the applicant on his complaint and the reminders, within 10 days of receipt of this decision.

- V. The appeal is being disposed of accordingly.
- VI. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
