## I. Brief Facts of the case:-

The applicant sought information with regard to non-compliance of three orders of the Commission. After receipt of the replies from concerned CPIOs, he submitted First Appeal in respect of the following queries No.15, 18, 19-27 relating to Appeal No.CIC/CCITD/A/2018/155167 & No.CIC/NDMC/A/2018/112333. ### II. Grounds for First Appeal:-

The appellant stated that CPIO vide letter No.CICOM/R/E/21/00044 dated 28.01.2021 failed to provide complete and correct information against Point Nos.15,18 & 19-27. The appellant requested FAA to direct PIO to provide point-wise complete and correct information as desired by him in his application dt.08.01.2021 against Point Nos.15, 18 & 19-27.

#### III. Decision with reasons:-

On perusal of the First Appeal petition, RTI application and reply given by the CPIO, it is observed that information given by Shri S.C.Sharma and Shri R.P.Grover, CPIOs is as per the provisions of the RTI Act, 2005.

As per the provision of Section 2(f) of RTI Act, 2005 only such information as is available and existing and held by the public authority or is under control of the public authority can be provided by a PIO. The PIO is not supposed to create or collect information that is not a part of the record. Therefore, no intervention is required on behalf of the FAA in this matter.

- IV. The appeal is being disposed of accordingly.
- V. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
