

III. FAA Decision with reasons:-

On perusal of the First Appeal petition, RTI application and reply given by the CPIO, it is observed that reply given by Shri S.K.Chitkara, CPIO, CIC is as per the provisions of the RTI Act, 2005. As per the provision of Section 2(f) of RTI Act, 2005 only such information as is available and existing and held by the public authority or is under control of the public authority can be provided by a PIO. The PIO is not supposed to create or collect information that is not a part of the record. He is also not required to interpret information or decision of CIC. Therefore, no intervention is required on behalf of the FAA in this matter.
