## 1. Brief Facts of the case:-

The applicant sought information with respect to his second appeals No.CIC/CGPDT/A/2019/ 110851. CIC/CGPDT/A/2019/100133. CIC/CGPDT/A/2019/169937 and CIC/CGPDT/A/ 2019/105232 and also the information relating to Ms. Vanaja N.Sarna, IC, CIC, New Delhi. The information sought by the applicant and the reply/information furnished by Shri Ram Kumar, CPIO, RTI Cell, CIC are as under.

It is needless to say that they are not the information available within the knowledge of the petitioner: on the other hand, admittedly, they are the documents of the second respondent himself, and therefore, if he does not have copies of the same, he has to blame himself and he cannot seek those details as a matter of right, thinking that the High Court will preserve his frivolous applications as treasures/valuable assets. Further, those documents cannot be brought under the definition "information" as defined u/s 2(t) of the RTI Act."

## II. Grounds for First Appeal:-

The appellant stated that he has received time-barred reply dated 02.02.2021 comprising arbitrary, evasive, strange, vague, baseless, wrong, biased, misconceived, irrelevant & contradictory statements and whimsical & unwarranted opinions, while without resorting to and/or appreciating the relevant provisions of the law as well as the purpose & scheme of the RTI Act ibid, purportedly with a view to give undue favour to the above-named Information Commissioner.

## III. Decision with reasons:-

The First Appeal petition, RTI application and reply given by the CPIO have been examined.

As per the provision of Section 2(f) of RTI Act, 2005 only such information as is available and existing and held by the public authority or is under control of the public authority can be provided by a PIO. The PIO is not supposed to create or collect information that is not a part of the record. As per decision of Hon'ble High Court of Delhi in the matter of Registrar of Companies &Ors vs. Dharemendra Kumar Garg & Ors [W.P.(C) 11271/2009], once information has been provided in public domain and on the website, the information is no longer held by or under the control of any public authority and hence, is no longer accessible as 'right to information'.

However, in view of the submissions made by the Appellant in his First Appeal, the CPIO is directed to revisit the replies of points (j), (v) and (xi) of the RTI application and give suitable reply as per the provisions of the RTI Act 2005, within 10 days from the date of receipt of this decision.

- IV. The appeal is being disposed of accordingly.
- In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
