I. Brief of the case:-

The information sought by the applicant and the reply given by Shri S.K.Chitkara, CPIO, CIC are as under.

Kindly provide the complete details of action taken upon it (complaint dated 19.03.2021 against MPSDC-Bhopal officials) and also provide the certified copy of the forwarding letter, through which my above stated complaint dated 19.03.2021 has been forwarded to MPSDC-Bhopal by Hon'ble CIC for necessary action.	-

II. Grounds for First Appeal:-

The appellant stated the following as the grounds for his First Appeal.

“...It seems that the concerned CPIO already got dispatched the reply/ information to me corresponding to my above stated RTI application, but my opponents have got blocked it ...”

III. Decision with reasons:-

On perusal of the First Appeal petition, RTI application and reply given by the CPIO, it is observed that the reply furnished by CPIO in respect of point-1 is appropriate and as per the provisions of the RTI Act, 2005. As RTI applicant has claimed non-receipt of information, CPIO may once again provide the information free of cost.

The CPIO is directed to provide appropriate reply / information in respect of point-2 also to the appellant within 10 days from the date of this decision.

IV. The appeal is being disposed of accordingly.

V. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he/she so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
