- (iv) According to your rules or- citizens charter or any other order in how many days should such a matter be dealt with and resolved. Please provide a copy of these rules.
- (v) The above officials have not adhered to the time limit mentioned in these rules. Are these officials guilty of violating these rules and hence guilty of misconduct under their conduct rules. Please give a copy of their conduct rule, which they have violated by violating the above mentioned rule.

- These officials have caused serious mental injury to me by making me run (vi) around all this while. Are these officials guilty of causing mental harassment to the public?
- What action can be taken against these officials for violating all the above (vii) rules and for causing mental agony to the public? By when this action would be taken?
- By when will by my problem be resolved now? (viii)
- Permission may please be grant to go before the Court of Law. (ix)
