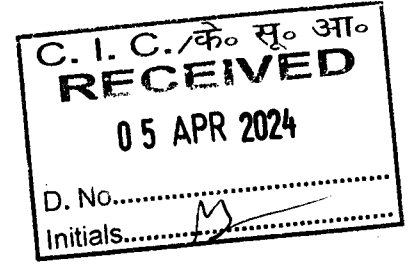

Brief Facts of the case:-

1. The Appellant has attached details with his RTI Application and sought the following information: -

- o/c
- Please provide the daily progress made on my application.
 - Please give the names and designation of the officials with whom my application was lying during this period. Please intimate the period when it was lying with which officer and what was the action taken by that official during that period.
 - Please give the proof of receipt and dispatch of my application in the office of each of these officials.
 - According to your rules – or- citizens charter or any other order in how many days should such a matter be dealt with and resolved. Please provide a copy of these rules.
 - The above officials have not adhered to the time limit mentioned in these rules. Are these officials guilty of violating these rules and hence guilty of misconduct under their conduct rules. Please give a copy of their conduct rule, which they have violated by violating the above mentioned rule.

- (vi) These officials have caused serious mental injury to me by making me run around all this while. Are these officials guilty of causing mental harassment to the public?
- (vii) What action can be taken against these officials for violating all the above rules and for causing mental agony to the public? By when this action would be taken?
- (viii) By when will my problem be resolved now?
- (ix) Permission may please be granted to go before the Court of Law.

Reply of CPIO:-

2. "The details of information sought vide RTI application no. CICOM/R/P/24/00044 dated 04.01.2024 from CPIO DR to IC- ~~VT~~ No reply has been furnished by CPIO (DR to IC- ~~VT~~) of CIC".

Ground of First Appeal:-

3. "That the CPIO subsequently handed over to me incomplete/misleading and false information with the covering letter no Nil dated Nil posted & received on dated Nil but para wise reply as per RTI act 2005, u/s 7(1) (9) and as per information seeker did not provided."

Decision with reasons:-

- 4. The First Appeal and the RTI application have been perused.
CPIO (DR to IC – UM) is directed to reply the RTI application as per the provisions of the RTI Act, 2005 by 15.04.2024, free of cost.
- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
