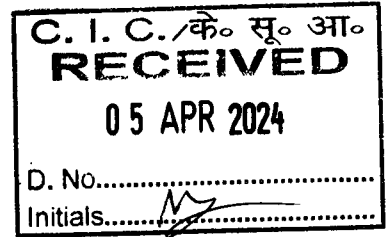

- There are some 93 Nos. of my appeals are in pending with CIC, belonging to the year 2008 to 2017 constant reminders are being forwarded from me, even then I am not able to get any information on the above figure of 93 Nos. of my pending appeals. I would like to know whether this pending of my appeals are being reviewed by the Chief of Administration in CIC periodically by the Registrar of CIC. Ground of First Appeal:-

3. Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

"The statement of DR to CR and CPIO of CIC. (Suman Bala) is not correct whereas the set of my appeal dated 14.09.2023 has already been sent to CPIO CIC vide my RTI Application dated 30.01.2024 by speed post R. No. EN 41381081N of 30.01.2024 and the same is also enclosed herewith for your action. However, an inquiry may please be conducted and also this appeal is sent to FAA of CIC for taking action under the provisions of section 19 (1) of the RTI Act and your kind orders are soliated on PRIORITY basis to the an appraisal to Honble Chief Information Commission CIC."


Decision with reasons:-

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO for points no. (v) Of the RTI application No CICOM/R/P/24/00049 is not as per the provision or RTI Act, 2005. Accordingly, direction is being given to CPIO, (DR to CR - I) to revisit the matter and provide complete appropriate information within 10 days of receipt of this order.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi - 110 067 against this order within 90 days.
