1. The Appellant seeks details/information with his RTI application and sought the following information:-

- i) Provide me the true copy's of my appeal no. 6454 of 2011; order dated 09.08.2021, stated in order dated 01.01.2024 resp. let me know.

**Reply of CPIO:-**

2. The sought information is a judgement of Hon'ble Supreme Court of India and the same is available in Public Domain.

**Ground of First Appeal:-**

3. The Appellant made appeal on following grounds:-

- i) As per my RTI Application dated 23.01.2024 in Ref. no. CICOM/R/P/24/00032 the O/o PIO states info. available in public domain but as per RTI Act, 2005, the Hon. CIC's order not quoted/cited with names of parties to Hon. CIC's order/ supporting the claim/statement of RTI reply of o/o PIO that info. available in public domain.
- ii) Hence kindly impose fine/penalty on o/o PIO for responsibility is not quoting Hon CIC's then order directions supporting his claim/ reply of order of Hon SIC available in public domain.
- iii) Also further no one contented this reply of public domain as RTI department of info. in section 2(f) of RTI Act, 2005 this claim of public domain is not there as per Hon CIC's order wrongly passed and not contested till date. Please note I will how contest section 2(f) does not contain the line of public domain. Please reply then how much order passed by o/o CIC as to availability of order in public domain. Further reply me. Let me know.


**Decisions with reasons:-**

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provision of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.


