 - iii) Provide me true copies of letter replied dated 26.11.2021 of (3) pages by Bank/Branch on pg (2), line (2). Let me know.

 - ii) Hence since info. not available on Commissioner record as stated in Hon IC's order FAA please impose fine/penalty and FIR/Police compliant against o/o PIO (Dy. Secy. DR to IC(AR) esp. for such a reply. Let me know

iii) No such reply given as jurisdiction reasoning, explanation as to the reason of nonavailability of info. as per reply given in point no. (3). Let me know

iv) The queries made and info/details sought by RTI appellant/ applicant are not mentioned, as per reply given that details not available. Let me know.

v) The o/o PIO has not stated date signature let me know.

Decisions with reasons:-

- On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the 4. information given by the CPIO is as per provision of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.
