Reply of CPIO:-

2. A copy of the letter dated 08.10.2021 is enclosed herewith. Further, it is stated that the letter dated 31.05.2021 as mentioned in your RTI application is not available on the Commission's record.

Ground of First Appeal:-

3. The Appellant made appeal on following grounds:-


- i) The queries /info./details sought made are not stated in RTI reply of o/o PIO dated 08.02.2024 on my RTI application dated 23.01.2024 resp. please reply. Let me know.
- ii) Please impose fine/penalty and file RTI police complaint on o/o PIO as to info/details not available as in point no (1). Let me know.
- iii) No reason/justification/explanation not for non-availability of details sought as per Hon IC's order as per RTI application dated 23.01.2024 made. Let me know. Provide me reply.

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provision of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi - 110067 against this order within 90 days.
