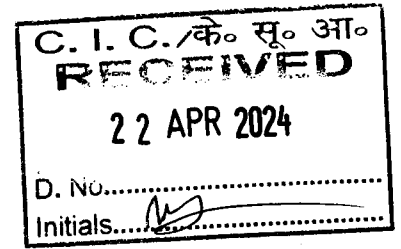

Brief Facts of the case:-

1. The Appellant has attached details of with his RTI Application and sought the following information: -

(i) A letter from O/o Hon' ble President of India Presidents Secretariat bearing no. P2/A/0401190035 dated 04.01.2019 duly enclosing a copy of my appeal dated 27.12.2018 on the subject cited.

(ii) DOPT: GO India letter no. 2/2/2019-RTIC/1351086 dated 08.01.2019 addressed to secretary, Central Information Commission.

(iii) Order of compliance of the orders of Commission dated 29th November, 2016 with file no. 11/JS/Law/2316-CIC-Circulated to all concerned GOI organizations forwarded to me vide CIC office letter dated 28.05.2021.

(iv) My appeal dated 14.10.2021 addressed to Shri Y.K. Sinha Hon'ble Chief Information Commission, C.I. Commission.

Reply of CPIO:-

2. (Point no. i) - Yes
(Point no. ii, iii) - Letter dated 07.07.2023 of Department of Legal Affairs received on 24.07.2023 in RTI Cell in Central Information Commission and was forwarded to the former CPIO Sh. R.P. Grover on 31.07.2023.

(Point no. iv) - No file noting has been prepared.

Ground of First Appeal:-

3. Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

“Madam, what are all prayed in this appeal from page no 1 to 6 are my complaints on the present CPIO of CIC who is not at all taking my interest to go through the old records towards my 172 nos. of my appeals/Rips. Are kept in pending in CIC from the year 2008 to 2017 and 2018 to till date like this I am kept in tension for the last 10 to 15 years, when I am repeatedly mentioning that necessary Xeroxing charges with also be paid reportedly on demand and in case if the registered records belonging to some period of 2008 & 2017 to 2019 are missing and cannot be taken up for Hearing of each pending 2nd Appeals in near future, I may make a report of the same and forward it to O/o Hon’ble President of India for their kind information and further necessary action.

As on today I also did not receive any communication/reply from the concerned CPIOs of CIC of the subject matters raised in my appeal dated 25.01.2024 (i.e. my RTI Application) vide in para no. s 1,2,3,4,5 and 6 as to CPIO of CIC Shri Babulal could answer only the points (i) to (iii) only. Therefore, I hereby make an appeal to you Madam to kindly take up the issues of mentioned paras 1,2,3,4,5 and 6 with the concerned other CPIOs of CIC.”


Decision with reasons:-

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO for points no. (iv) Of the RTI application No CICOM/R/P/24/00050/1 is not as per the provision of RTI Act, 2005. Accordingly, direction is being given to CPIO, (Dak Section) to revisit the matter and provide complete appropriate information within 10 days of receipt of this order.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
