Brief Facts of the case:-

- 1. The Appellant has attached details of with his RTI Application and sought the following information: -
 - 1.) Copy of my letter of 16/1/2024
 - 2.) Copy of your letter of 24/01/2024

Please note that I am sending you back copy of my letter of 16/01/2024 along with all necessary enclosure for your ready reference. You have unnecessarily sent back the papers to me without stating any valid reason for doing so. All documents pertaining to the case have already been sent per the procedure outlined by your end and all discrepancies. Till date I have not received any valid and favorable response to the original complaint of 04/03/2020, First Appeal of 10/06/2022 and Second Appeal of 20/02/2023 inspite of several RTIs and reminders sent to your end."

Reply of CPIO:-

2. "As per software of the Commission, communication/second appeal of Kaushalya Devi has been received in the Commission and diarized vide diary no. 109524 dated 27.02.2023 and returned to sender vide facilitation memo no. 109524/2023 dated 03.03.2023 (Copy enclosed)."

Ground of First Appeal:-

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated 3. that:

"Please note that till date I have not received that valid and required response to my original complaint of 04/03/2020, First Appeal of 10/06/2022 and Second Appeal of 20/02/2023. Furthermore, the enclosed copies of the documents will reveal to you that all necessary formalities you had and have still outlined and documents you have asked for have already been sent to you. In spite of this still you are repeatedly and unreasonably asking for the same documents not just this, several RTIs and reminders sent to your end have not yielded the desired results per my query of 04/03/2020. You are requested to look into the matter and do the needful."

Decision with reasons:-

- On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO for the RTI application No CICOM/R/P/24/00078 is not as per the provision or RTI Act, 2005. Accordingly, direction is being given to CPIO, (Dak Section) to revisit the matter and provide complete appropriate information within 10 days of receipt of this order.
- The appeal is being disposed of accordingly. 5.
- In case the Appellant is aggrieved by the decision, he is free to file second appeal, if 6. he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
