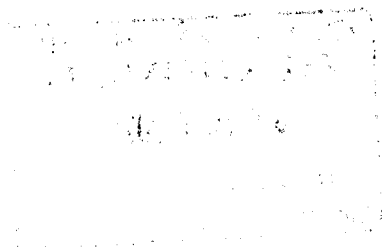
**Brief Facts of the case:-**

1. The Appellant has attached details of with his RTI Application and sought the following information: -

“Kindly refer my letter dated 23.11.2023 (copy enclosed) and request you to kindly provide a copy of action taken report and status report as on date.”

**Reply of CPIO:-**

2. “As per records No Compliance has been from the Public Authority till date. Your matter is being taken up with Public Authority for compliance of same at an early date.”



### Ground of First Appeal:-

3. Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

"I am to invite your kind attention towards my RTI application dated 28.12.2023 submitted to PIO CIC New Delhi, and to any that the requisite information has not been provided by the PIO. Hence it is deemed refused. You are requested to take action under RTI act and provide the information please."


### Decision with reasons:-

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO for the RTI application No CICOM/R/P/24/00005 is not as per the provision or RTI Act, 2005. Accordingly, direction is being given to CPIO, (DR to IC VT) to revisit the matter and provide complete appropriate information within 10 days of receipt of this order.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
