- (vi) Any notice for final decision will be issue in future.

Reply of CPIO:-

 Point (1) – No final decision taken on your non – compliance complaints. Point (2 to 4) – No time frame can be given for final decision on non – compliance complaint. Point (5) No Notice has been sent.

Ground of First Appeal:-

3. Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

"For not giving any reply w.r.t point – VI and being dissatisfied with the reply dated 10.05.2024 of CPIO, I am approaching before you proper Justice."

Decision with reasons:-

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that no information has been given by the CPIO for point's no. VI, of the RTI application No CICOM/P/24/00173. Accordingly, direction is being given to CPIO, (DR to CIC) point no VI to revisit the matter and provide complete appropriate information within 10 days of receipt of this order.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
