Brief Facts of the case:-

1. The Appellant has attached details of with his RTI Application and sought the following information: -

“As mentioned is the Annexure relating to the Protest Petition dated 15.02.2024 filed by this applicant in view of the delay on the part of the Central Information Commissioner, CIC, New Delhi to pass a speaking order on my Second Appeal pending with the CIC vide file no CIC/UTPON/A/2021/128204 (Diary No. 105259 dt. 19.02.2024)”

Reply of CPIO:-

2. “CIC vide its letter dated 03.01.2024 had directed the respondent to file a report to compliance of its order dated 29.07.2022. However, no reply has

been received from respondent. The Dy. No. 105259 dated 19.02.2024 has been kept pending in view of our letter dated 03.01.2024.”

Ground of First Appeal:-

3. Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

“PIO did not furnish any satisfactory reply but simply mentioned that the file is pending for want of response from the respondent since 03.01.2024.”

Decision with reasons:-

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
