**Brief Facts of the case:-**

1. The Appellant has attached details of with his RTI Application and sought the following information: -

“(a) Please Let me know the Status and Action taken by your CIC office on the – RTI Second Appeal (Ref No. RTI/130524/Appeal, dated 13-05-2024) sent by Track on courier (Consignment No. 111196285 dated 13-05-2024) delivered at your office on dated 16-05-2024 (as per enclosed tracking report/POD)?

(b) Please provide the details of Appellate Authority?”

**Reply of CPIO's:-**

2. “Point (a) – Your second appeal dated 13.05.2024 diarized vide diary No. 115242 dated 15.05.2024 has been registered vide file No. CIC/CCAKP/A/2024/115242.

Point (b) - Brig. Vipin Chakrawarti, Registrar & First Appellate Authority Room No. 105, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi – 110067.

**Ground of First Appeal:-**

3. Aggrieved with the reply of CPIO's, the Appellant has filed First Appeal and stated that:

"Request information in enclosed RTI application (Ref No. RTI/030724 dated 03.07.2024) about the present status and action been taken by your CIC office has not been provided in Point no. (a) of your enclosed RTI reply no. CICOM/R/P/24/00289, dated 16.07.2024 as no reply has been received till date on the RTI Second Appeal (Ref No. RTI/130524/Appeal, dated 13-05-2024) filed by the application though it has been more than 30 days."

**Decision with reasons:-**

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. You have written in your first appeal that I have not received any reply from CPIO's yet whereas the reply has sent on 16.07.2024. Therefore, CPIO's reply is being attached with the first Appeal order. No, further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi - 110 067 against this order within 90 days.
