- IPO No. 62F 098138 dated 13.08.2024 for Rs 10/- towards my RTI Application dated 08.08.2024 as IPO sent in favour of CPIO of CIC instead of PIO CIC, New Delhi.

The information sought by the appellant is not clear.


Decision with reasons:-
