Brief Facts of the case:-

1. The Appellant has attached details of with his RTI Application and sought the following information: -

"Enclosed please find my letter 18.07.2024 which remains answered by your end till. I am enclosing Indian Postal Order number 52F 0182219 dated 28.08.2022 for Rs 10/- under the Right to Information Act of 2005 for you to do the needful please."

Reply of CPIO's:-

"As per available records, your letter dated 18.07.2024 has been received and diarized in CIC vide diary no. 123216 dated 19.07.2024 and the same has been link with file no. CIC/CISFO/A/2019/115839."

Ground of First Appeal:-

3. Aggrieved with the reply of CPIO's, the Appellant has filed First Appeal and stated that:

"Please note that your response per the underlined portion in your letter of 17.09.2024 does not satisfy me at all. My letter of 18.07.2024 mentions about various other letters having remained unanswered validly with the required answers till date in spite of several RTIs and remains to be answered validly with the required answer and it is further left to be seen how many more RTIs and reminders need to be sent to all concerned ends till I get the valid and required responses from the concerned ends. You are therefore requested to look into the matter and do the needful."

Decision with reasons:-

- 4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.
- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
