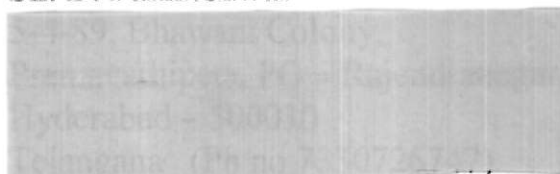

Brief Facts of the case:-

1. The Appellant has attached details of with his RTI Application and sought the following information: -

2. Reply of CPIO's:-

“With reference of your RTI application dated 08.08.2024 received on 20.08.2024, it is intimated that you are seeking information with reference to CIC Decision dated 24.05.2021 and 15.02.2023. You have not mentioned the second appeal or complaint number of the decisions. You are requested to seek information as defined in section 2 (f) of the RTI Act, 2005. You are requested to indicate the second number or complaint number with reference to which the documents are being sought by you.”

Ground of First Appeal:-

3. Aggrieved with the reply of CPIO's, the Appellant has filed First Appeal and stated that:

“The information sought by in your first appeal is not clear.”

Decision with reasons:-

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
