**Brief Facts of the case:-**

1. The Appellant has attached details of with his RTI Application and sought the following information: -

B. Kindly provide the hearing Date & Status in the Case/Diary No: CIC/SBIND/C/2023/118758

C. Please provide the certified copy of complaint copy with attached all reference documents and all link documents uploaded by the applicant

in the Diary no. is 639466 (Case/Diary No. CIC/SBIND/C/2023/118758)

D. Please provide the certified copy of all documents/affidavit submitted by the respondent in the Case/Diary No: CIC/SBIND/C/2023/118758.

**Reply of CPIO's:-**

“Point A - The hearing notice has been issued via barcode ED899785330IN. You may check the delivery status through India Post Office/Tracking website.

Point 3 (B) – Cases already heard and disposed off. No further intervention is required in the said case at CIC.

**Ground of First Appeal:-**

3. Aggrieved with the reply of CPIO's, the Appellant has filed First Appeal and stated that:

“I painfully states that The Public Information Officers did not provide the requested information and I have not satisfied with that reply, And bar code ED899785330IN did not deliver to the applicant, attached the postal tracking details. Kindly request to the Registrar & First Appellate Authority, O/o Central Information Commission, CIC Bhawan, Baba Gang Nath Marg, Staff Quarters, Old JNU Campus, New Delhi that provide the instructions to the Public Information Officer, O/o Central Information Commission, CIC Bhawan, to provide the request information as soon as possible.”

**Decision with reasons:-**

4. On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
