1. The Appellant has attached details of with his RTI Application and sought the following information: -

I am also not able to get any information/record the details of disposals here in Computers shop. Because, I do not have computer and also no knowledge of it, at my age of 82 years now.

I shall be grateful to you Sir, if you could kindly make arrangements to send me a copy of details of its disposal for my record in file. Please help me Sir."

## 2. Reply of CPIO's:-

"I am to refer to RTI application of Shri B Parameshwar, which has been registered vide no. CICOM/R/P/24/00379. It has been received through online RTI-MIS from RTI – Cell on 06.09.2024 with a request to provide information sought for by the appellant. The information is as under: -

### 3. Ground of First Appeal:-

Aggrieved with the reply of CPIO's, the Appellant has filed First Appeal and stated that:

"This is to intimate that I did not get any response from CPIO (RTI Cell), CIC New Delhi. This is for kind information and further necessary action."

#### 4. Decision with reasons:-

On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. But in your first appeal you have said that you have not yet received any reply from the CPIO has sent it only on 25.09.2024. A copy of which is being attached with this order. Therefore, no further intervention is required on the part of FAA in the matter.

- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
