Since, the contents of Dy. No 127196 dated 22.08.2024 and Dy. No. 100668 dated 05.01.2024 were same, no action on Dy. No. 127196 and 22.08.2024 is warranted. Point xv) – Case has already been heard and dismissed on 23.02.2024.

### 3. Ground of First Appeal:-

Aggrieved with the reply of CPIO's, the Appellant has filed First Appeal and stated that:

"That till this Appeal date, No Information has been provided by the "Competent CPIO" of the CIC, New Delhi 67, in the desired "Certified Copies form" which were Sought for, through the afore RTI Application on 16 specific points, except the irrelevant nature Pieces of Information Supplies by some other Officials of the CIC, New Delhi 67, which can be evidenced from the enclosed Copies of Letters to this Ist Appeal in question, & through these issued Letters, 2 Officials have the "Commonality nature advices in Writing" sending to this RTI Application to Approach to the Ist Appellate Authority to the CIC, is not satisfied.

### 4. Decision with reasons:-

The First Appeal, RTI application and reply given by CPIO's of CIC have been perused.

As per Section 2 (f) of the RTI Act, 2005 only such information as is available and existing and held by the public authority or is under control of the public authority can be provided by a PIO. The PIO is not supposed to create or collate information that is not a part of the record. Accordingly, the reply given by the CPIO is appropriate and as per provisions of the RTI Act, 2005. Hence, no intervention is required on behalf of the FAA in this matter. 5. The appeal is being disposed of accordingly.

6.In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
