Brief Facts of the case:-

1. The Appellant has attached details of with his RTI Application and sought the following information: -

"I have sent 2 Non – Compliance complaints Dated 28.08.2024. Diary Nos 127734 & 127888 dated 28.08.2024

So Hon'ble CPIO please accept my RTI Application, take a serious action on Income Tax Department (INV) officers and issue the asking information per my complaint Dated 24.08.2024 save public money. The Income – Tax Department (INV) officers, not Implementation your orders. So please suspend. The officers and issues the asking information. If any mistakes in the RTI application please excuse me Sir. Awaiting for your positive Reply. "Thanking you

2. Reply of CPIO:-

"As per record available, no reply have received from concern CPIO till now, therefore, further process in this matter will be initiated at the earliest."

3. Ground of First Appeal:

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

"Dated 06.12.2024 I have sent on RTI application for, what kind of action you have taken my Non – compliance complaints Dated 24.08.2024. The Dairy Nos – 127734/24 and 127888/24. But your office CPIO not respond and not issue and information till today. He is crossed the RTI Act 2005, limits. The non – compliance complaints Nos – 1.) CIC/DITIN/A/2017/155081- BJ. 2.) CIC/CBODT/A/2023/116352. A. Ramalingam dated 07.12.2018. I have sent a non – compliance complaint. But your office is not respond till today. Dated 16.07.2024 the CIC, Hearing case no CIC/CBODT/A/2023/116352. But these is no issue. So Honourable FAA, please accept my Ist Appeal and issue the asking information as per non – compliance complaints & RTI application – 06.12.2024."

4. Decision with reasons:-

On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. Therefore, no further intervention is required on the part of FAA in the matter.

- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
