**1. Brief Facts of the case:-**

The Appellant has attached details of with his RTI Application and sought the following information: -

“(i) Please furnish/provide the copy of multiples Action Taken Report (ATR), who/whom has been taken by above mentioned Central Information Commission (CIC) & other concerned authority & officials of CIC, Delhi/Government of India, regarding above said complaint/letter/correspondence no 917/2018, Dak CIC from 2018 to present/till day /date.

(ii) Please provide the copy of daily progress Report & Status Report upon/ over above mentioned complaint/letter/ correspondence no 917 /2018, Dak. CIC.

(iii) Please provide the copy of file noting of any materials in any form including copy of all records & documents from 2018 to present day/till date regarding above mentioned complaint /letter / correspondence no 917/2018, Dak, CIC.

(a) The copy of any circulars, ATR, Press releases, notification, memos, data materials, e mails, SMS, judgments & orders, samples, models, ordinances, advices & opinions, logobooks, work papers, daily progress report & status Report & etc,

(b) The copy of data materials held in any digital/electronically form.”

**2. Reply of CPIO:-**

“Point i, ii & iii – Information pertains to complaint/correspondence no. 917/2018 has been registered as First Appeal no. CICOM/A/2018/00187 and has been disposed off on order of FAA on 09.08.2018. The copy of the same has been sent to you on 10.08.2018 (copy enclosed).

**3. Ground of First Appeal:-**

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

Non/None receipt of any reply/information from above mentioned CPIO/PIO over / upon three points so far, The copy of RTI Application dt 21.01.2025, Postal receipt are annexed on page 03-08.

Prayer / relief, please direct the above mentioned CPIO/PIO to provide correct & true reply / information & take appropriate legal action against above mentioned CPIO/PIO expeditiously in interest of justice. I hereby state that the information & particulars given above said true & correct to the best of my knowledge & belief.

**4. Decision with reasons:-**

On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. You have written in your first appeal that I have not received any reply from CPIO's yet whereas the reply has sent on 25.02.2025. Therefore, CPIO's reply is being attached with the first Appeal order. No, further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
