



1. Brief Facts of the case:-

The Appellant has attached details of with his RTI Application and sought the following information: -

“Most respectfully, I beg to enclose on application fee of Rs 10/- by way of Postal order payable to the Accounts officer, Centra Information Commission, Baba Gang Nath Marg, Munirka, New Delh– 110067. As the 90 days of 2nd appeal is over, I therefore, request to decide the 2nd appeal pending before CIC for allotment of alternative plots in lieu of the fertile agricultural land vide Award No – 36 dt 19.06.1980 F. Nos. – 32(31)/789/80- LOB (Alt).”

2. Reply of CPIO:-

“No such information has been sought in your RTI Application.”

3. Ground of First Appeal:-

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

I am to refer sought for by the appellant. The information is as under:- No information has been sought in your RTI application. It is also informed within 30 days of receipt of the letter before Brig. Vipin Chakrawarti, Registrar & First Appellate Authority (FAA). CIC Bhawan Baba Gang Nath Marg, Munirka, New Delhi – 110067. As the time limit of 90 days of 2nd appeal is over. Therefore, request to decide the 2nd appeal pending before CIC for allotment of alternative plots 36 dt 19.06.1980 F. Nos. – 32(31)/789/80- LOB (Alt). A First Appeal under the RTI Act, 2005 against the above reply within 30 days of receipt of this letter.”

4. Decision with reasons:-

The First Appeal, RTI application and reply given by CPIO of CIC have been perused. As per Section 2 (f) of the RTI Act, 2005 only such information as is available and existing and held by the public authority or is under control of the public authority can be provided by a PIO. The PIO is not supposed to create or collate information that is not a part of the record. Accordingly, the reply given by the CPIO is appropriate and as per provisions of the RTI Act, 2005. Hence, no intervention is required on behalf of the FAA in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
