1. Brief Facts of the case:-

The Appellant has attached details of with his RTI Application and sought the following information: -

- “1. Copy of my letter of 07/01/2025.
2. Copy of my letter of 05/11/2024.
3. Copy of my letter of 20/08/2024 which is an RTI in connection with my letter of 18/07/2024.
4. Copy of letter of 18/07/2024 (mentioning about various letters which remain unanswered by you validly with specific answers till date.)

5. Copy of my letter of 20/08/2024 (with special reference to the underline portions.)

6. Copy of your Decision of 19/04/2024 (with special reference of the underlined portion.)

Please note that several RTIs and reminders have been sent to your end in respect of the aforesaid letters but none of the letters have been answered by you till date with any valid and specific answers.”

2. Reply of CPIO:-

Point 1.) Information sought by you in your RTI application is not clear.

Point 2.) Your Second Appeal/Complaint dated 05.11.2024 received by the commission on 06.11.2024 and diarized vide Dy.No. 135807. The same is Facilitation Memo in which it has been conveyed that your Second Appeal/Complaint has returned to you vide letter dated 11.11.2024 (copy enclosed) for removing deficiencies with request to resubmit Second Appeal/Complaint complete in all respects.

Point 3, 5 & 6.) Information sought by you in your RTI Application is not clear.

Point 4.) The RTI application that your letter dated 18.07.2024 has been linked with second appeal no. CIC/CISFO/A/2019/115839. No action is warranted on this letter dated 18.07.204 as your second appeals CIC/CISFO/A/2019/115839 and CIC/CISFO/A/2019/125659 have already been disposed of vide letter order dated 11.08.2021.

3. Ground of First Appeal:-

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

As concerns the double ticked portions of your aforesaid letters please note that I am not satisfied by the responses received. I will be satisfied when I get valid and specific responses for each of my letters listed as numbers 1 to 6 in my said and enclosed letter of 18/07/2024 and further satisfied when I get my Husband's family Pension from C.I.S.F with effect from March 2003 onwards with respect to the aforesaid newspaper article which is the Ruling and Decision of the Supreme Court of India, and also with respect to the order dated 21.03.2018 of the Chief Information Commissioner. Please note that my Husband's Family Pension for me from C.I.S.F is my legal right and I must get it. This is for your information and doing the needful please.

4. Decision with reasons:-

The First Appeal, RTI application and reply given by CPIO of CIC have been perused. Accordingly, the reply given by the CPIO is appropriate and as per provisions of the RTI Act, 2005. Hence, no intervention is required on behalf of the FAA in this matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
