1. Brief Facts of the case:-

The Appellant has attached details of with his RTI Application and sought the following information: -

“I, Sheeja S, presently residing at Nakramkottu veedu, Avanavachery P.O., Thiruvananthapuram, Kerala, 695103, wish to seek information, under the RTI Act, 2005. The information needed pertains to the CBI, us per details given below :

- 1.) A comprehensive report regarding the proceedings and investigation done by CBI on my complaint dated 11.03.2015
- 2.) It is certified that I am a bona fide Citizen of India.”

2. Reply of CPIO:-

“The information sought pertains to CBI and should be obtained from CBI. In case there is direction form the Commission in a decided case

then Appellant should file a Non – Compliance directly on CIC Website citing Case no of case decided by the Commission.”

3. Ground of First Appeal:-

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

Though I have sought information regarding a complaint and its status, made at CBI, the complaint and its status, made at CBI, the information was not provided to me and an unsatisfactory reply was sent instead. A comprehensive report regarding the proceedings and investigation done by the CBI on my complaint dated 11.03.2015 Ref file no. CIC/CBRUI/A/2021/119993). The reply was unsatisfactory and no information sought for were provided.

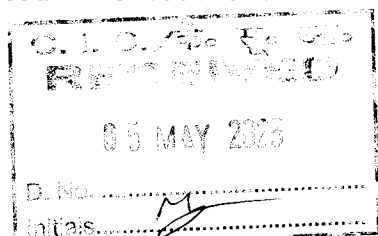
4. Decision with reasons:-

On perusal of the Appeal, RTI application and reply of the CPIO, it is observed that the information given by the CPIO is as per provisions of the RTI Act, 2005. You have written in your first appeal that I have not received any reply from CPIO's whereas the reply has sent on 10.03.2025. Therefore, CPIO's reply is being attached with the first Appeal order. No, further intervention is required on the part of FAA in the matter.

5. The appeal is being disposed of accordingly.

6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi – 110 067 against this order within 90 days.
