1. Brief Facts of the case:-

- (b) Appellant can visit the office of Registry of IC AR in Room 416 on any working day and inspect the records available with Registry.

3. Ground of First Appeal:-

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

- (a) Summons the entire records relating to the case of the appellant.
- (b) Issue directions to the CPIO of your office for supply of complete and correct information's /attested documents as asked in the application dated 22.02.2025 preferred under RTI Act, 2005 (Annexure A -1).
- (c) Pass any other orders or directions as your honour may deem fit in facts and circumstances of the case of the appellant.
- (d) Allow the appeal.


4. Decision with reasons:-

The First Appeal, RTI application and reply given by CPIO of CIC have been perused. Accordingly, direction is being given to CPIO, (DR to IC AR) to revisit the matter and provide complete appropriate information within 10 days of receipt of this order.

5. The appeal is being disposed of accordingly.


