1. Brief Facts of the case:-

The Appellant has attached details of with his RTI Application and sought the following information: -

"In the light of my grievance request letter dated 27.12.2024 (copy attached) regarding denial of inspection of records and non – compliance of CIC 2nd appeal no. – CIC/NCCLD/A/2023/143837 by the CVO/CPIO BCCL Dhanbad please inform the status of suitable action taken against the concerned CPIO BCCL Dhanbad and CVO BCCL Dhanbad for compliance of reasoned order passed by Central Information Commissioner New Delhi as per RTI Act 2005."

2. Reply of CPIO:-

"With reference to your RTI application dated 34.02.2025 received on 04.03.2025, it is intimated that your non-compliance complaint dated 27.12.2024 has been sent to the CPIO, Bharat Cooking Coal Ltd. for

comments vide letter No. CIC/NCCLD/A/2023/143837 dated 07.03.2025."

3. Ground of First Appeal:-

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

I have not got the compliance report with comment of the CPIO BCCL Dhanbad and concerned vigilance department regarding inspection of record which has been demanded by the Dy. Registrar CIC New Delhi vide letter dated 07.03.2025 within 3 weeks. Please pass suitable order.

4. Decision with reasons:-

The First Appeal, RTI application and reply given by CPIO of CIC have been perused. Accordingly, the reply given by the CPIO is appropriate and as per provisions of the RTI Act, 2005. Hence, no intervention is required on behalf of the FAA in this matter.

- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
