## 1. Brief Facts of the case:-

The Appellant has attached details of with his RTI Application and sought the following information: -

V "Please find enclosed the above cited two (02) complaints, dated 30.09.2024, which were sent by Indian National Registered Post of kind consideration of H'ble IC & H/E Sir, Shri Vinod Kumar Tiwari jee please.

Now u/s 6 (2) of RTI Act 2005, may I kindly request your good self that to please provide me the certified copies of all correspondences, noting's actions taken by his good office & replies received/given as yet either by RDSO/LKO & IRWO/NDLS, in these matter.

2. If no action has been taken as yet, the copy of decision & rule/regulation/precedence/norms/ethics/guidelines etc., under which it

was decided that not take any action may please be intimated to the under signed please Sir."

2. Reply of CPIO:-

- "(i) No action has been taken on the complaints dated 30.09.2024 filled against the CIC Order Nos. CIC/MORLY/A/2023/118624 and CIC/MORLY/A/2023/142476. Your complaints dated 30.09.2024 alleging against the CPIO/Deemed PIO and seeking Commissions interventions, are grievances in nature. The Commission in its order dated 21.08.2024 in both files nos. CIC/MORLY/A/2023/118624 and CIC/MORLY/A/2023/142476 had upheld the reply provided by the CPIO in response to your RTI application dated 01.02.2023 and 04.08.2023 respectively and closed the matter.
  - (ii) With reference to point (2) no Rules/Instruction exist."

3. Ground of First Appeal:-

Aggrieved with the reply of CPIO, the Appellant has filed First Appeal and stated that:

Please find enclosed above cited my RTI Application, dt 08.04.2025, which is self – explanatory. However it is informed that u/s 6 (2) of RTI Act, 2005, a request was made to provide the certified copies of all correspondences, noting's, actions taken up till now by your good office & replies received /given either by the renowned offices of RDSO/LKO & IRWO/NDLS. But it seems that no heeds was paid to respond within a stipulate under RTI Act 2005. Hence this first appeal is cropped from here to file please.

Being aggrieved with the decision that no action to be taken. Now may I have the privileges to obtain the certified copy of decision & rule/regulation/precedence/norms/ethics/guideline ect., under which a decision was taken that not take any action may please be provided to undersigned appellant please Sir.

Further I take a dare to put up my first appeal u/s 19 (1) along with section 20 (1) & (2) of RTI Act- 2005 with a request to provide me the requisite information under the Hon'ble CIC's rules of addressing each query in one to one format & also like to imposed penalties/punishments as carved u/s 20 (i) & (ii) of RTI Act 2005 upon erring officials, with an intimation to under signed please.

## 4. Decision with reasons:-

The First Appeal, RTI application and reply given by CPIO of CIC have been perused. Accordingly, the reply given by the CPIO is appropriate

and as per provisions of the RTI Act, 2005. Hence, no intervention is required on behalf of the FAA in this matter.

- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi  $-110\,067$  against this order within 90 days.
